The emulsified fuels gave a reduction in PM 10 emissions of 34% (for 13% water) and 43% (for 18% water) and a reduction in NOx emissions of 16% (for 13% water) and 27% (for 18% water). A fuel efficiency advantage of more than 5% was recorded.
